MPA – Call off procedure: recommended quality criteria.

(towards DAE Target 2020)

Availability of 2-way telecommunications services via satellite with speed of at least:

- 6 Mbps in download and 2 Mbps pload, throughout the entire territory covered by the measure.
- Global traffic volume a wance (download+upload) of at least 3 GB/month
- Availability of residual connectivity at no cost for the enduser, possibly with reduced performance, when reaching the maximum volume allowance.







MPA – Call off procedure: further info from resellers

- Company's data and contact details;
- A statement confirming eligibility requirements (i.e.: specific General Authorization from the Competent Authorization something equivalent), to ensure it is fully entitled to provide the service.
- Availability of 2-way telecommunications services via satellite with capacity of at least 2 Mb/download to bughout the territory covered by the measure);
- The description of the activities proposed on the market, including at least:
 - download an (u) load connection speed
 - traffic management policies
 - service subscription prices, including VAT, and excluding any temporary special offers

MPA – Competitive Selection Process

Public Authority identifies the eligible area

Mapping and analisys of the coverage

Consultation

Cost benefit analysis of the various solutions for broadband connectivity (suggested)



PA: call-off procedure

selection of satellite broadband service providers with characteristics in line with the scheme.



Agreement Public Authority and Resellers

the reporting and monitoring system in accordance with the rules approved within the relevant legislation.







MPA – From End-User point of view

Public Authority provides Voucher for eligible end-user

serial number identification

total cost for the user terminal including installation

electronically managed and controlled by the PAs



information identifying the end-user

Service provider chosen within the selected list

declaration of eligibility

120 days validity

End—user gives the voucher to the service provider

Public Authority payment to the Service Provider after the submission of a detailed report (that includes the vouchers) of each user terminal installed







Financial management

For both MPA and the SPA payment through the service provider

• SPA: service providers, before proceeding with the on-site supply have to check with the managing Authority the actual availability of funds.

regular reports submitted by the service providers to the Managing Authority:

- User identification code
- MAC address (Media Access Control)
- A statement of delivery, installation and activation for the user equipment,
- The delivery address
- References of the service contract for a term of at least 24 months

The Public Authorities will monitor the implementation of this part of the Scheme and will ensure the aid is reimbursed in the event of non-compliance by the operator.







The Audit System - on the spot check procedure

Main considerations for the random on the spot check procedure

- high number of end-users
- excessive travelling time during the audit and consequent high cost for the PAs

strongly suggested to proceed firstly auditing the service providers as final beneficiaries. In case of irregularities:

- Second level: check if the satellite operator effectively provides the service to the specific final recipient
- Third level: final recipients

NB: an alternative to the on-the spot check, the inclusion of geo-referenced photos of the ground equipment installed (modem and antenna), to be included in the installation report to the PA, along with the print out of the speed test (countersigned by the end-user) could ideally be considered sufficient to give evidence of the actual deployment of the subsidized broadband access.
